बादशाह के क्लब पर
विस्फोट के मामले में गोल्डी
बराड़ से जुड़ा गुर्गा गिरफ्तार

दिल्ली पुलिस के विशेष प्रकोष्ठ (स्पेशल सेल) ने पिछले साल चंडीगढ़ के दो वलब पर हुए बम हमले के सिलसिले में कनाडा से रह रहे सरगना (गैंगस्टर) गोलीबाज से जुड़े एक व्यक्ति को गिरफ्तार किया है। इनमें से एक वलब गायक बादशाह का है। सूत्र ने बताया कि आरोपी दीपक पंजाब के फरीदकोट का निवासी है और उसे दिल्ली में गिरफ्तार किया गया। पिछले साल 27 नवंबर को चंडीगढ़ सेक्टर 26 में दो वलब के बाहर दो विस्फोट हुए थे। इनमें से एक, बादशाह के स्वामित्व वाला सेविले बार एंड लाउज है और दूसरा स्थानीय व्यवसायी के स्वामित्व वाला डॉ. आर्य वलब है। विस्फोटों से छिड़कियों के शीशे टूट गए थे, लेकिन किसी के हताहत होने की खबर नहीं थी। दीपक कथित तौर पर बरार के लगातार संपर्क में था, जिससे घटना के कुछ घंटों बाद एक कथित जम्मूतला मीडिया पोस्ट में विस्फोटों की जिम्मेदारी ली थी। सूत्र ने बताया कि इस पोस्ट में एक अन्य गिरोहबाज की संलिप्तता का भी जिक्र था।
